SUBJECT: Policy Memorandum # 24, **USASMA Parking Policy**

1. References:

- a. AR 190-5, Motor Vehicle Traffic Supervision, dated 22 May 2006
- b. Fort Bliss Regulation 190-5, Installation Traffic Management, dated 3 Jun 13

2. Purpose: To designate parking areas and specify parking guidance for USASMA students, staff, and faculty.

3. The Academy's north, south and interior east parking lots are "parking by permit only" parking lots as authorized by applicable Army and installation regulations. The USASMA Security Manager is responsible for issuance of USASMA Parking decals to assigned staff and faculty members. USASMA Parking decals should be displayed in the bottom left corner of the windshield (vicinity of state registration and safety stickers).

4. USASMA students may park in paved lots available on the south side of Sergeants Major Boulevard, the north side of MSG Miller Street, and within the gravel lots to the east and west of the Academy. Paved open parking is also available within the exterior portion of the Academy's east parking lot and along the northwest side of Wright Street. Students are prohibited from parking within the Academy's north and south parking lots and interior portion of the east parking lot.

5. Spaces or areas reserved for the disabled, military vehicles, loading zones, fire department access, and/or free flow of traffic will be enforced IAW Texas State law by military police. Additionally, driving and/or parking on any landscaped area (vegetation or xeriscaping) or "jumping" the curb along any street or parking area is prohibited. A limited number of parking spaces will be designated for USASMA leadership and visitors. These reservations will be respected by the command.

6. Motorcycles do not require parking decals. In exception to line 4, USASMA motorcyclists (students, staff, or faculty) may use any parking space specifically designated for motorcycles in any USASMA parking lot.

7. The VIP drive/circle may only be used by visiting distinguished visitors or through special arrangement with Operations and/or Protocol.

8. All personnel will exercise caution when driving or walking to, from, or through parking lots. Personnel may only cross Sergeants Major Boulevard at the marked cross-walks.

9. Commanders will enforce and ensure compliance of this policy by their assigned personnel. Military police will be contacted to enforce violations of state motor vehicle laws.
